APPROVAL OF CONSENT AGENDA:

Motion was made by D. Wheeler, seconded by M. Ekhoff, to approve the consent agenda as follows:

<u>ADMINISTRATOR'S REPORTS:</u> The administrators' reports are attached. Ms. Planeta added Grandparents' Day was a resounding success. Close to 400 lunches were served and many compliments were received on the meal and the helpfulness of the volunteer NJHS students. Mr. Sanidas noted the MS play was very successful and well attended. He complimented all those involved. He also reported on GPHS students recent

accomplishments: All-Area Boys Soccer – Connor Claussen, Kaleb Lehnert; All-Area 1st Team Volleyball – Holly Anderson; and Jake Perreira signing Letter of Intent for baseball at University of Indianapolis.

Superintendent: Dr. Palan's report included:

- 1. The Schedule of Waiver of Limitation of Administrative Costs is scheduled for December 15, 2014 at 6:45 p.m. in the MS Library. This is necessary due to exceeding the 5% cost increase on this budget line item because of having a Special Education Director on the payroll this year as opposed to sharing the position with St. George last year.
- 2. The Leadership Summit in February 2015 which will be discussing Vision 20:20.
- 3. Another Legislative update on SB 16, Pension Reform and the Cost Shift which may have a very detrimental effect on the district.
- 4. An in-depth review on the District/School Report on State Assessments from 2013-14. In summary, GPES scored a composite of 72.4% versus a state average of 59% on the ISAT, the highest of all Kankakee County schools. GPHS showed a composite ACT score of 22.2 compared to a state composite of 20.7. This is their highest average in comparison to the last five years. Dr. Palan will be providing further information to various media outlets.
- 5. The current enrollment update shows no change from the previous month.

DISCUSSION OF THE 2014 TAX LEVY AND SETTING A HEARING DATE FOR DECEMBER 15TH:

Dr. Palan has been working on the levy but is waiting for the cash flow numbers at the end of November to finalize the tax levy amount. The Board set the hearing date for Monday, December 15th at 7:10 p.m. in the MS library.

BOARD COMMITTEE REPORTS:

President: The Illinois Association of School Boards would like GP to pilot a Community Engagement Program. A tentative date for the first session was set for Saturday, January 24th.

Building and Grounds: The committee received a proposal to re-do the baseball field, at no cost to the district. Work has not been started yet due to the weather.

Technology: Two committee members visited the classroom using the Chromebooks for the 1:1 Initiative and were impressed with the students' use of the technology. Also, Dr. Palan noted the technology infrastructure will need updating in the very near future.

Kankakee Area Special Education Co-op: No report.

Kankakee Area Career Center: The audit report was given at the last meeting. Also, GPHS junior, Melissa DuMontelle, was selected KACC Student of the Quarter – CNA.

IASB-Three Rivers Division: No further report.

Chamber of Commerce: Christmas in the Village was discussed at the recent meeting.

Student Representatives: The Jazz Band concert will be held Tuesday evening; Spanish classes will take a field trip to a Mexican Museum and restaurant; Girls Basketball is in full swing; and there have been two issues of the school newspaper.

Board Communications: An article entitled, "Local Schools Feel Pinch of Drop in Education" was distributed to the board.

COMMUNITY FORUM AND OTHER: There were no questions or comments from the audience.
