**ADMINISTRATOR'S REPORTS:** The administrators' reports are attached.

Superintendent: Dr. Palan's report included:

- 1. Information on the potential dissolution process for the KASEC is included for board members to review.
- 2. There is current legislation pending regarding a property tax freeze proposed by the Governor which would affect school funding. More information on the levy and CPI will be available at the November meeting.

- 3. The unofficial composite scores from PAARC will be released soon and the entire state's scores are down. ACT and SAT are in the bidding process and depending on the results, Dr. Palan may propose that the district become an ACT testing site and cover the expense for student testing.
- 4. An enrollment update which shows an increase of five students over last month.

# **DECISION ON DATE FOR BOARD SELF-EVALUATION PROCESS:**

## TRS ON-BEHALF PAYMENT FOR BUDGET FY 16:

The TRS on-behalf payment has been added to the final fiscal 2016 budget. It is a "wash" item and the amount is based on last year's TRS report.

**Building and Grounds:** There has still been no response from the general contractor, manufacturer or installer regarding the MS tile issue. The district attorney will be contacted to discuss the next course of action and hopefully come to a resolution.

**Technology:** 1:1 Initiative is going well.

**Kankakee Area Special Education Co-op:** The superintendents met recently to continue discussions on the fate of the Co-op. Momence announced that they, too, may withdraw from the Co-op. When districts leave the Co-op they also forfeit rights to any assets. If the member districts agree to dissolve, all of the assets would be divided among those remaining. At this point, much is still left to be determined.

**Kankakee Area Career Center:** The next meeting will be held on November 12<sup>th</sup>. **IASB-Three Rivers Division:** The division meeting is on October 29<sup>th</sup>.

**Chamber of Commerce:** The next meeting will be held on November 11<sup>th</sup>. Christmas in the Village is scheduled for December 12<sup>th</sup>.

**Student Representatives:** This week is Spirit Week in preparation for the Mean Green Goes Pink event on Friday, October 23<sup>rd</sup>.
