In the absence of a secretary, a motion was made by J. Loitz, seconded by C. Horn, to appoint V. Gawlinski as Secretary Pro tem for this meeting. Roll Call: J. Loitz – yes; C. Horn – yes; H. O'Nions - yes; V. Gawlinski - yes; and T. Markland – yes. Motion carried unanimously.

Danielle Schlosser was introduced as the candidate for the 5th grade teaching position.

ADMINISTRATOR'S REPORTS: The administrators' reports are attached. Ms. Planeta added the ES students are extremely excited to be back to school for full days and the ES staff are working on Scope/Sequence and Thematic Units to be in place for next school year. Mr. Maxwell announced the soccer team won the SEC Conference Tournament, two State Scholars were selected (Paige Sherwood and Vaughn Paape) and the end of year events are being organized.
