














PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

Grant Park Elementary and Middle School teachers and students strive to achieve in all areas, not only those that are tested. Grant Park Elementary students scored 8.3 points above the state average in all combined areas.

The 2012 ISAT results for Grant Park Elementary School show: In grades three thru eight, 88.2% of our student met or exceeded standards in Reading. In grades three thru eight, 92.1% of our students met or exceeded standards in Mathematics. In fourth grade, 90.7% of our students met or exceeded standards in Science.

In seventh grade, 91.7% of our students met or exceeded standards in Science.

Plans for improvement include the continuation of data team meetings in a K-5 and 6-12 format. These meetings will focus on aligning instruction to increase areas of student achievement. Particular attention will be aimed at increasing student achievement levels of our subgroups. The crosswalk to the common core standards will continue. The Elementary School has in place learning expectations for all areas of the common core standards. Discovery Education Testing to benchmark students will be done three times a year in grades two thru eight and DIBELS testing will take place three times a year in grades kindergarten thru third. A dedicated shut down time for response to intervention (RtI) in grades kindergarten thru five will ensure optimal success for all our students. The added tutorial time at the end of the day in the Middle School will allow teachers the opportunity to focus on skill remediation with students.

The Administration has made it a priority and commitment to increase visibility in the classrooms. Administrators will incorporate learning walks to actively gauge and monitor quality instruction that is being provided to the students of Grant Park.

Lastly, it is important to understand that we as a school are committed to placing the best interest of all our students first.
